Writing Under Socialism

Using a comparative approach that crosses disciplines and continents, *Writing under Socialism* offers a critical reevaluation of the position of literary production under socialist states past and present using new material, theories and methodologies that have come to light since 1989.

The volume brings together academic experts researching the interactions between writing and politics in diverse contexts across the former Eastern Bloc, Latin America, and China. In contrast with literary production under capitalist regimes, writers living under socialism have had to negotiate a role for themselves and their writing within an institutional framework defined by a specific political and ideological value-system and entirely administered by the state. Whilst socialist regimes tend to place a high value on literary practice, they also find it a source of potential political subversion. It is the nature of this contradiction that has attracted the attention of numerous researchers in the past.


However, as the contributions to this volume demonstrate, writing under socialism involves more than the traditional dichotomy of intellect versus power and instead includes complex relationships between the different actors, institutions and policies that together form the context of literary production in a given state. By offering fresh perspectives on writing in a range of socialist countries, *Writing under Socialism* highlights the commonalities and differences in these complex relationships.

Writing under Socialism will be of direct interest to scholars working on literary, historical and political analyses of cultural production under socialisms past and present.



The dictatorships of Chile and Argentina lasted from 1973 to 1989 and from 1976 to 1983, respectively. The two countries have thus long since entered the time of commemoration and of a new politics of memory. How, though, to remember and commemorate trauma as a political body, without reducing memory and commemoration to political calculation?

New social movements have proposed a different sociability of mourning (one is not supposed to dance at funerals...), a new politics and culture of affect. Social media allow us to remember traumas that were never experienced first-hand. More than ever, memory is mediated by technology. This volume examines such matters in a series of essays covering the centres of detention, museums and memory sites, film, documentary, television, theatre, fiction and the press, LGBT and other testimonies, education, accusatory practices, the


politics of memory and mourning, and the Abuelas of the Plaza de Mayo. They deal with the memory, commemoration and trauma of the Pinochet and March 1976 coups, and of the Falklands-Malvinas war in an exploration of post-dictatorship Argentina and Chile. Recent military interventions in Rwanda, Somalia, the former Yugoslavia, Afghanistan and Iraq, amongst others, have placed conflict again at the forefront of international debate. Yet the theoretical analysis of conflicts and of their social and psychological impacts has predictably lagged behind such tumultuous events. Moreover, while scholarship in the areas of strategic studies, international relations and peace studies has addressed the issues in terms of "conflict resolution" and "post-conflict reconstruction", little or no attention has been given to crucial interrelations between conflict and culture.

Bringing together international experts from disciplines as diverse as Political Science, History, International Law, Media Studies, Visual Culture, Critical Theory and Semiotics, *Post-Conflict Cultures: Rituals of Representation* therefore employs an avowedly interdisciplinary approach in order to address what the editors perceive to be a significant omission. In five themed sections, this ambitious volume tackles many


questions often excluded from discourses on conflict. How does a past conflict inform a community's vision for its future? How are conflicts represented in the media, in literature, in journalism, in all forms of cultural expression? How do representations of conflict compound but also confuse, and even reconfigure, cultural identities? What role do histories of conflicts play in the construction of national identities?

Post-Conflict Reconstructions brings together specialists in diverse fields in an attempt to foster dialogues across disciplinary borders, spanning four continents within a comparative framework. It covers Geography, Urban Planning, International Relations, Social Sciences, Semiotics, Law, Critical Theory, Cultural Studies, Aesthetics, Literary and Film Studies, highlighting the dislocations and de-territorialising effects of the geopolitical dimensions of past and present conflicts, at a time when political discussion is increasingly reduced to engineered bureaucratic and technical policies of consensus, albeit presented as apolitical and post-ideological.


(e.g. urban planning and distribution of natural resources) or at a discursive level (e.g. historical representations, political reform). Analysis of colonial cartographies and post-colonial contestations, urban reconstruction, water and nature preservation policies as well as varied artistic and cultural media (visual art and photography, literature, film, cartoons and popular songs) draws attention to the persistence of conflicting agendas, motivations and tensions which are an inescapable dimension of negotiations leading potentially to post-conflict reconciliation.

The late Keith Sagar produced over fifty years a stream of essays, introductions and lectures on Lawrence, fourteen of which are collected here. Four have not been previously published, and this collection brings most of others back into print.

Of Keith Sagar's first book, *The Art of D. H. Lawrence* (1966), Vivian de Sola Pinto wrote that it marked the start of serious Lawrence scholarship in England. Alastair Niven described Sagar's *Calendar of Lawrence's Works* (1979) as "indispensable, fascinating and almost certainly as authoritative a literary calendar as we could expect for any writer". John Worthen described *The Life of D. H. Lawrence* (1980) as "the best single-volume biography of Lawrence". Keith Brown, reviewing *D. H. Lawrence: Life into Art* in the *Times Literary Supplement* in 1985 wrote: "Criticism of Dr Sagar's book is well-nigh impossible. It is clearly going to be there as long as formal Lawrence studies survive". Of his later book, *D. H. Lawrence: Poet* (2008), Christopher Pollnitz wrote: "Keith Sagar has done more than any other critic to reshape understanding of Lawrence as poet."



This study revisits Novalis's *Heinrich von Ofterdingen* (1802), offering a ground-breaking alchemical interpretation of this quintessential Romantic novel. While alchemy is not the exclusive key to *Heinrich von Ofterdingen*, this study positions it as a rich interpretative

framework, connecting Novalis's work to contemporary discourses in literature, philosophy, and cultural studies. Ultimately, the book reaffirms alchemy's enduring relevance in understanding transformation, both poetic and existential.



Reflections on South African Fiction in English

Elizabeth Taylor's reflections on South African fiction are rooted in the political and social realities which dictated, until the democratic era, the preoccupations of most writing produced in the country: the politics of oppression and dispossession, identity and racism, gender and miscegenation.

From Olive Schreiner's *Story of an African Farm* (1883) to Sol T. Plaatje's *Mhudi* (1930), from Alan Paton's *Cry, the Beloved Country* (1948) to Zoë Wicomb's *You Can't Get Lost in Cape Town* (1987), from Nadine Gordimer's *July's People* (1981) to J. M. Coetzee's *Disgrace* (1999), Zakes Mda's *Madonna of Excelsior* (2002) and André Brink's *Philida* (2012), she traces the intimate relationship between politics and literature in this work, and the evolution of greater creative freedom in South African fiction under democratic rule.

She concludes by demonstrating that, while South Africa today may not be a perfect nation state, at least all its people


from all backgrounds are now at liberty to write about it as they choose.

Elizabeth Taylor grew up in British India and South Africa and is uniquely positioned to examine the colonial legacy. Under apartheid she witnessed first-hand the struggle amongst people of all ethnic backgrounds to find a way of combatting and enduring the situation. Before embarking on her doctorate at Rhodes University (Grahamstown), Elizabeth (Betty) Taylor published travelogues on the Transkei in South African newspapers such as the Cape Times, the Cape Argus and the Eastern Province Herald. Later, while employed as a lecturer in English Literature at Rhodes, she completed a pioneering thesis on early poetry in English written at the Cape. One of the poets dealt with in her thesis, the Scot Thomas Pringle, appears in this book. She then moved to England, where she was appointed to a lectureship at the University of Nottingham. At the height of European opposition to and awareness of apartheid she introduced students to South African fiction in English. She continued to explore South African fiction with successive generations of students long after Nelson Mandela had retired from public life, taking great pleasure in the emergence of a multiplicity of new writers in the post-apartheid era.

It is said that we live in anti-Hegelian times. Criticism of Hegel's philosophy of history highlights its exclusion of non-European cultures and subordinate groups from the story of the Modern Age. But, Sharman argues, to imagine that Hegelianism can be overcome simply by incorporating excluded ethnic and social groups is not only unwittingly to confirm Hegel's account of history as the progressive realization of freedom for all; it is to stumble into unforeseen complicities with the New World Order. Drawing on the work of Derrida, Althusser and Žižek, the book will be of interest to students of Hegel, and to scholars in the fields of postcolonialism and modernity.



Keen is the first to analyse them in a scholarly way in their biographical and historical context, and shows that no one has yet really come to grips with the Ali evidence and how much it contributes, not only to Ali's biography but also to our understanding of the FBI in the period and within the wider history of the 1960s. He argues convincingly that the FBI's attention to Ali was not merely part of its broader investigation of the Nation of Islam movement to which Ali belonged. It was pursued and extended because of Ali's outspoken challenges to white America and the Vietnam War and the effect his words and actions had as the most famous sportsman in the world. By engaging with the historiography on the FBI, Keen explores how perceptions of the federal agency have changed as its shield of secrecy has been gradually dissolved. Particular focus is placed upon the overbearing influence on its activities of the Bureau's Director, J. Edgar Hoover, especially in its counter-intelligence program. Keen shows how Ali acted "subversively" on multiple fronts, and how these must therefore be seen in the context of Hoover's own personal beliefs about what America should look like and what sort of behaviour could be tolerated. Exploring the FBI's reaction to Ali's involvement in the "semi-religious group", the Nation of Islam, reveals Hoover's anxieties over Ali's devotion to Elijah Muhammad's interpretation of Islam, as well as his radical standpoint on race relations. Keen's analysis of the correlation between FBI surveillance and Ali's increasingly public anti-Vietnam War stance also highlights the significance of Ali's politically symbolic refusal to join the armed forces, and of the movement that he stirred.
